

## Notice of change in share capital

Milan, 6<sup>th</sup> August 2021 – BFF Bank S.p.A. (“**BFF**” or the “**Bank**”), pursuant to Article 85-bis of CONSOB Issuers’ Regulation n° 11971/1999 as subsequently amended, communicates the new composition of its share capital (fully subscribed and paid-in), following the partial execution of the share capital increase free of charge resolved by the Bank’s Shareholders’ Meeting on 2<sup>nd</sup> April 2020 (“**Share Capital Increase Free of Charge**”).

As a result of the execution of the Share Capital Increase Free of Charge, over the period between 19<sup>th</sup> July 2021 and 5<sup>th</sup> August 2021, BFF’s share capital increased by an amount equal to Euro 17,126,34, through the issuance of 22,242 new BFF ordinary shares, assigned to BFF Group’s employees in relation with the remuneration and incentive policies’ requirements, in the context of:

- (i) the *Management by Objective* incentive system;
- (ii) the “*Stock Option Plan of Banca Farmafactoring Banking Group*” originally approved by the Shareholders’ Meeting on 5<sup>th</sup> December 2016, and modified by the Shareholders’ Meeting of 28<sup>th</sup> March 2019 (“**Stock Option Plan 2016**”).

The certificate of the change in share capital was filed with the Companies’ Registration List of Milan, Monza Brianza and Lodi, on 16<sup>th</sup> July 2021.

With reference to the Stock Option Plan 2016, it should be further noted that, from the beginning of the exercise period (8<sup>th</sup> April 2019) until 5<sup>th</sup> August 2021, 1,234,360 shares (of which 841,285 newly issued) were assigned, against 5,185,392 options exercised on a cash-less basis and 401,638 options exercised with the ordinary method over the same period. The number of

options assigned and not exercised yet to date amounts to 2,746,150, of which 1,777,150 are vested and exercisable options.
